

At evening assemblies, either have entertainment OR speaker.

20 Minutes for prof. improvement seminars instead of 15 – hard to communicate much in 10 minutes plus 5 for questions.

30 hour days

A facility with more things within walking distance.

A venue for breakfast

Offer continental breakfast morning breaks

Hold it in facilities with an economical breakfast or else with small fridges and microwaves in the rooms.

Allow for tickets to tours to be included in packets

Include facilities map in registration packet.

An activity during the breaks to encourage agents to meet with other agents to establish networks.

Barbecue night out location on Wednesday – location was too distant the convention center. Shuttles worked well, but there was nothing special about the location to warrant the round trip.

Being from NC, I spent most of my time working during the conference. I did get to attend some of the workshops. I felt that most of the events, tours, etc. went well. Some parts of the program booklet seemed difficult to understand, and improvement could be made in the future on program booklets.

Better (more extensive and more convenient) recycling. Less obvious use of and emphasis on alcohol consumption.

Singing at opening ceremony too long.

Better seating for large meals.

Bigger rooms for hospitalities

Maybe have the posters up longer. Didn't get to see them all.

Choice of where to stay without penalty for staying in conference hotel.

Continue the quality of this year.

Could lunch and learn sessions be made available to those who want to come listen without attending lunch? I realize some are more formal and this may not be possible but it seems that there are some this would lend themselves to.

Don't allot specific time to poster and trade show, allow participants to view at own time.

Felt the schedule was packed and not enough time to view posters or meet exhibitors.

Folks working the Information Booth needs to know what is going on and where it is being held.

For first timers develop a flow diagram of the organizations structure.

Good conference – session lengths on Tuesday afternoon were quite short at 20 minutes and no time was available if you wanted to go to a different group without disrupting one room.

Impress the importance of speakers starting and ending on time (Tuesday's sessions) ...leaving more time to get from one session to another.

Have more ½ day tours.

On the Professional tours, try to keep the travel on the bus shorter.

Have more topics on horticulture also have some sessions on retirement.

Have more youth professional improvement opportunities.

Have the trade show only open certain hours as opposed to all day. Not have any other "classes/breakout sessions" for attendants at those times so they would visit the trade show. Seems like I sat there all day long with vast periods that no one visited my booth because they were all attending classes/sessions downstairs.

I am an exhibitor (Nasco) but I have been coming for a number of years, the exhibits were the best attended of any of the years I have attended. I just hope that what was learned can be moved to the states that host the meeting in the future.

Having coffee and water service out sooner in the exhibit hall.

Help the next state with ideas especially on how you went about getting sponsors for N. Carolina.

**Higher Level Educational Seminars** 

How big a deal is the State Picture to everyone? Has it passed its time?

I have attended MANY large conferences in my career and this was one of the best organized events to date. As a first timer, I was sorry that my program conflicted with the first-timers luncheon as the very few things that I missed knowing were surely covered there.

I like the idea of maybe having the tour day as the last day, but still having the fairgrounds type meal and some entertainment. It seems like Thursday is mostly wasted except for the banquet. This is my ninth meeting so I know that breaks tradition. I missed late Sunday and early Monday. Did we have a motivational speaker? I might do that one of the last two days.

I would have liked a map listing where all the rooms were in our book. I was also really confused about the breaks. I wish there were more topics about beef cattle.

I would improve it by supplying sitter service for small children not involved in the youth programs so the meetings would not be interrupted by unruly children.

If NACAA is going to have national awards and contests, then after the judging occurs at the annual conference, then have a follow-up workshop to explain how to submit national award entries and build posters correctly. If is ridiculous to have a "professional improvement" conference when there is no attempt to teach and show agents, especially new members and young agents, how to create posters correctly and submit awards entries properly. There was no explanation or justification on the judging and why some entries won and why others did not. Much of the competition rules are very vague in content and difficult to understand. Such

negligence only frustrates members to not participate in future conferences nor submit awards entries in the future.

In all Award presentations, the title of the winning paper along with all authors should be printed in the handout. Please make it clear beforehand regarding who will be given award at the stage and who do not be there for the award show (Communication Award had a confusing format).

Have all awards luncheons or breakfasts at different times/days so people don't have to choose which to go to and which to miss, especially those agents who enter multiple award programs.

Look carefully at time schedule for opening session agenda.

Improve the 4-H talent show!

In the future, work to keep the professional development tracks closer together, especially the rooms for the individual tracks like Animal Science, Agronomy, etc. The animal science rooms were about as far apart as you can get in the conference facility. Also - for next year's president - the meet the author session for the poster display needs to be sometime different than against a sponsored lunch. It was a waste of my time and several of the other authors seemed to feel the same way.

Keep up the good work in providing outstanding professional improvement opportunities.

Larger rooms for session, maybe less sessions and offer more than one time, there were several ones I would have liked to attend, but could not because there was something else I felt I needed more.

Less time in general sessions. Opening program too long. Shorter speeches or fewer speakers in general sessions/opening ceremony & banquet. Can't sit that long. More on programming/program delivery/case studies from county agents.

Longer registration (self serve is possible)

Make name tags so they show on both sides or ones that do not turn over.

Manned a booth and did not attend any sessions. There was very little food traffic but that is not ones fault.

Maybe allow more free time or down time during the days of professional development seminars – say run them from 8 to 2 or 8 to 3 and allow a little more free time between daytime sessions and night time activities.

Maybe more abstracts or meetings for people involved in horticulture/vegetable production.

More horticulture seminars for new plant materials.

Meeting etiquette needs to be improved, too many side conversations during presentations and too many cell phones ringing during meetings and presentations.

Milk at tables during meals.

Need to have meal choices for children. None of the meals were kid friendly. States Night In was the works meal for kids.

More informational sessions and cover more what first timers should do/how the times/talks work. I thought I had to sit through the whole series of talks on the one day but found out I could move around. Or just have brief descriptions of what they are, such as Bayer discussing products compare to new technologies/getting basic info on something

More opportunity to attend workshops.

More side tours. Someone from a tourism office available for the first day or two.

More time for agents to meet in specific areas of assignment. Example: animal science or horticulture or vegetable to talk about specific problems and solutions common to the nation.

More time for site visits, less seminars.

More time.

More to do on Thursday (professionally)

More Urban program sessions

More visits from agents to booths

Get program information to the host state much sooner. All meal functions should require preregistration so as to avoid the number of meals served and paid that were not consumed.

Not eating off the grounds after the tour day. Or making transportation available back to the hotel immediately for people that will be traveling home that day.

Not have the meeting rooms so cold.

Only glitch on my part was the hotel was not available for shuttle service on Saturday when we arrived. We had to wait until the North Carolina hosts taxied us to the hotel. Very small inconvenience for an excellent conference.

Open-ended response

Orientation for new comers

Provide an example judging score sheet for the poster session in the NACCA County Agent publication.

Raise the temperature of meeting rooms, air conditioning was too cold. Waited in line for a couple of buffet meals and for buses after the BBQ. Need to drop the 4:30 sessions on Tue. as no one attends

Seating arrangements for the states night in was confusing. But I like the idea of states night dinner being held in the hotel.

Shorten the "officer installations" even more during the awards banquet. Limit the focus of that event to recognizing the DSA candidates

Shorter opening session, with speakers that relate to all of the agents.

Slightly shorter tradeshow hours, during sessions there isn't much traffic.

The banquet meal was excellent but the servings were far too large.

Using two screens was a good idea however; the picture quality was questionable.

The BBQ meal at the fairgrounds was a little weak. The beer and BBQ sampling area outside needed a better set up so we could enjoy the very good food and drink that was available.

The conference brochure was a bit confusing.

The number of people attending can create "bottlenecks" in processing, so this could flow more smoothly. It was done very well for the professional tours loading up in the morning.

The on-line pre-registration form more user friendly.

The photography. How much would it cost to hire a photographer and have them work for us. In other words, all pictures would belong to the organization and would be available for everyone. As a national's award winner, it would be nice to have pictures to include with press releases, but the pictures never arrive until 4-8 weeks after the meeting and by then it is old news and they are useless for publicity for the counties or the universities.

The tours did not live up to my expectations. The tour I was on did not match the summary posted in the magazine.

There are some aspects of the schedule that are confusing. It's not always clear on some of the luncheons who's supposed to attend, or who can attend. For folks that haven't attended very many AM/PICs, that can be confusing.

There are times such as the Wed. night dinner when loud music makes it difficult to visit with others at the table. Not a major problem, but just a suggestion.

This is very important...the moderators need to be very diligent about staying on time!

Too much extra going on during state's night in.

Tours & time. Tours lasted longer than planned. Enjoyed all, however if a person has made plans based on times posted need to try to stay close to times.

Tours need to have less time spent standing around and listening to someone just talk-- you need to see more things in action. Tours need to be described better.

Trade show hours way to long, line it up where vendors get in front of agents.

Turn on the dehumidifier a day before the conference.

When I was seeking information at the information desk, difficult to find answers to questions. Those at the desk were very nice but would send me to another individual who was not familiar with details of the conference either. However, I thought the overall conference was very good.

While I appreciated the opportunity for a break on Thursday afternoon, it was partly because there didn't seem to be many options for sessions to participate in.

With spouses and members registration separate, we get two copies of all the material and discard a lot of it, especially the tourism stuff. Publish pick up time for spouses gift if not available the entire conference.

With the days switched at the Portland meeting, would like to see the posters stay up longer. For some really involved individuals it's difficult to find time to read the posters unless you review them after 10 PM.

Liked the closeness of the poster session to the exhibitor booths and the meeting rooms close by also.


When representing GLCI/NRCS at trade shows I have never participated in an event where I felt more welcome and appreciated. Thank you. Michael Hall, USDA-NRCS



## **5. The Professional Improvement choices were?**



1. Eliminate the flag ceremony and the patriotic video in the opening session. 2. Introduce committee chairs only at opening ceremony not at the banquet. 3. Focus of banquet should be DSA, take time to at least tell where they work and a major point about their career. 4. I am anxious to see how moving tours to Thursday works out.

Need biosecurity measures on tours.

Allow poster setup any time the day before judging.

Certified Crop Advisor continuing education credits were available at some sessions but were not announced prior to the meeting, that I was aware of. It would be nice to see a list of sessions having CCA CEU's at the time of registration for the meeting. That way CCA's could register for those sessions.

Charging DSA winners more to attend the banquet they already spent extra money to attend. I really did not appreciate finding that out when I arrived.

Communication from committee chairs to award winners could be improved. I was a state winner in one program and never received a note as to whether I should attend the awards lunch or not.

Put more professional improvement workshops on Thursday, during committee workshops since few attend those

Don't let industry vendors lead the professional improvement sessions; too biased. Use Extension folks from across the country do the sessions.

Also, the 4-H talent show is enjoyable, when I attend, but seems that the expense outweighs the positives, and just because we have always had it does not mean we need to continue to have it.

Eliminate candidate nomination speeches from unopposed offices. We heard their talks 3 separate times! I go to meetings for the networking and substance; not for the feel-good talks or extra fluff to fill time.

Explain why posters won and why they were chosen.

Fewer breakfast meetings.

Financial assistance.

I am involved in other organizations and would like to see more Professional Improvement workshops where we can learn what our peers are doing, rather than attending sponsored lunches. One afternoon is not enough to hear about the fabulous programs that are out there.

I am relatively new to extension and this is only my second NACAA, so I don't know the history of the changes, however I like all of it so far. Sometimes I think we don't get much time to network with colleagues of our own specific areas. (ex. crops, beef, plants)

I guess something to draw people to the Morning sessions. Door prizes were good but not sure it solved the problem.

I have a concern. It seems some administrators are looking very closely at the agent's role in attending out-of-state conferences. If they do not have an important role like officer, committee chair, poster or oral presenter they may not receive travel authorization. This may hurt attendance and the presenters may be presenting to empty rooms or only a handful of participants. This may be an opportunity to encourage committee membership participation with committee members having assignments from the national committee chairs to fulfill for the committee meeting at the AM/PIC. That could help them justify their attendance with administrators. Not sure this will work, but it is something to consider. Basically what can NACAA do to help NACAA members justify their attendance?

I like the idea of switching the Professional tours to Thursday to save rental costs. I hope it works.

I presented a poster - it'd be nice if they didn't have to be up until Monday vs. on Sunday.

I struggle to always find PI workshops that fit my needs. My luck is the ones I want to attend are always the same time. (I know that is just the luck of the draw - just venting.)

I thought the food was so/so. Too much chicken and I was not impressed by the seafood. In fact, we skipped States Night In and went to find some BEEF.

I was very impressed with the entire program. The Georgia Group on Sunday evening was excellent and because of the length of their program and because the Chancellor made a long speech before the introduction the Featured Speaker had to cut his speech short.

Some things need to be geared toward younger agents.

I would prefer to get a synopsis of each of the candidates by email before the meeting. Some hard concrete ideas on why they are the best candidates. The 2-minute speeches at the regional meetings are redundant. Having run for office, the process could be streamlined and reviewed so it was more effective and less stressful for everyone.

Improve handling of large numbers of people in coordinating events.

It is a busy few days, maybe work in some break times.

It was just a little too long. It's tough to be away for a full week. But I don't think that this was North Carolina's problem.

Just need to remember that they are county agent meetings...spouse and children programs are great, but don't benefit all members, and should not preclude the mission of the meetings.

Ladies & Gentlemen, it was a breath of fresh air. So don't be offended if I breeze past some of the repetitive questions in search of something negative. You started out right Sunday night with the opening session of God, Family, and Country. THEN work was excellent and sometimes forgotten in our secular institution.

Many of the introductions and welcome speeches should be done via video.

Maybe change time of introduction of board members and officers as much.

More diversity in Programs.

More generic activities for male spouses.

More regional trainings.

MORE SUBJECT MATTER OPPORTUNITIES IN PROFESSIONAL DEVELOPMENT SESSIONS. IT WOULD BE NICE TO HAVE AN AFTERNOON OPEN WITH NOTHING SCHEDULED FOR FAMILY TIME/SIGHTSEEING.

More time for presentation of new ideas and more time to share what works with colleagues from across the nation.

More times for luncheons so agents could attend more than one in their area over the week.

Need a clapper machine during the banquet rather than requiring people to clap their hands for every award presented.

Need to be mindful in all activities that not all participants are of the Christian Faith.

Notification of state officers about the presidents' luncheon on Tuesday prior to the meeting. Only attended 2 so far. Need a few more under my belt to make fair decisions.

Please don't put cheese or salad dressing/mayonnaise on food (sandwiches) unless the eater asks for it.

Poster session and organization can be greatly improved; quality of posters outstanding! Banquet could be held on Tuesday or Wednesday. States-Night-In was unnecessary.

Professional Improvement Tours seem to be more of a sightseeing tour rather than touring hands-on operations. i.e. it'd be good to see a real working cow/calf operation rather than the "show place" operations.

Provide more professional improvement sessions either with more presentations by agents, specialists or industry representatives. Select a more entertaining city or location.

Registration on-line. It was hard to navigate through.

Return the VIP/Heritage event!!!!

Something needs to be created that explains what it says in the program booklet so first or second timers know what it means. It's if you have been coming to these for a while but if you don't know the routine, you don't know if you are supposed to attend a committee meeting or a luncheon or a regional meeting

States need a night out.

Sunday should be removed. We should observe this day. Then set up posters late Sunday, if members wish to, and early Monday morning. Judges can score posters Monday afternoon or Tuesday morning.

The 4-H talent program lacked the normal quality, the MC sounded rehearsed and not connected with the acts.

The animal science/livestock presentation seminars were poor. Some kind of tougher screening needs to be done. Many of the presentations were on local programming that included educational tips and youth events that are not of interest to a broad audience. Many of them were very "elementary" and did not include real research or demonstration data.

The annual business meeting. Limit the campaigning time spent by the candidates running for office during the meeting. This should be time when voting is done. The campaign speeches should have been done prior to the business meeting.

The Annual Banquet needs to be shortened. Why do we need to introduce all the people over again all of them have been introduced three or four times before? Why do we need to have the

DSA's march in, go ahead and seat them and have them stand by region if you need to recognize them.

The conference is outstanding but too long for current times. We all live busier lives now. How about starting on Sunday night with short general session, then Monday and Tuesday professional development and Wednesday tours?

The ice cream social was the pits! Push up ice cream and fruit bars thrown out on a table is not my idea of an ice cream social. If you can't do real ice cream (dipped out of an ice cream tub), don't do it.

The lunches that are all paid for by the host state. If someone eats, they should pay unless covered by the registration fee.

The only thing I thought could've run a little better was the live auction...it went a little too long and the auctioneers could've moved it a long a little better.

The patriotic video should be eliminated. Patriotism is a lot more than supporting the military. I don't get the connection between patriotism, guns and war with what I do as an ag agent. It was offensive to me.

They did a good job of promoting what NC had to offer.





There to support the efforts Agriculture Cooperative Extension agents







## 18. Do you plan to attend the 2009 NACAA AM/PIC in Portland, Oregon?



### 29. Should taking state pictures continue?








## 32. Did you use the AM/PIC Computer Technology Lab?

Speakers should wear microphones, adjust microphone according to speaker. Inspirational speakers should be able to move on the stage without a podium because they are not formal tight speeches.



States' Night In was too noisy.







If you're taking the day to travel anyway, leaving at 5 AM or 6 AM should be an option to get to more distant locations if getting back in time for the meal is the problem. Don't restrict the chance to visit parts of a given state just because the bus schedule might have to be adjusted.

Anyone/everyone can sleep on a bus!

Small children can be quite disruptive on these tours and I suggest children under 12 not be allowed to go on the PI tours.

Have someone tell about agriculture and other points of interest during travel to stops

Having knowledgeable tour guide on bus and stops with something to see and hosts that are prepared are the key... like on the tour I attended.

Host on bus discussing surrounding sites and items of interest during travel.

I had trouble registering for the tours, so I didn't get my first choice of tours. I still like my tour a lot, however it would have been nice to combine some intense beef herds with the lesser intense ones were, so essentially to have both tour groups be able to overlap and each get to see some things. I don't know if that was possible-just a thought.

I like tours that give a sampling of AG in the region instead of just a hort, livestock or crop tour.

I thought we spent too much time at some sites and not enough at others...maybe trying to pack in too much??

It's always good to have historical stops blended into the tours, maybe even some dedicated to them.

Make them entertaining. Tours are supposed to be FUN and educational, but we don't won't to develop a nutrient management plan on tour...

Please use portable PA system.

Provide a list of dos and don'ts to participants, kind of a request list. Some participants asked too many disruptive question to company personnel/host which interfered with my learning experience. A gentle reminder list for appropriate behavior will be great.

Provide tour tickets with the registration packet. Or else have registration personnel stress the need to pick up the tickets.

Recruit a few first timers at AM/PIC to help plan future meetings. We need to keep up with the times.

Short web casts previews of "what you will see" on the tour that could accompany the registration information.

Showcase the region.

Split group into 2 smaller groups so everyone can see and hear.

The NC and Oregon videos were great.

Tour hosts could give more commentary of the state, area, ag, issues, etc.

Variety of stops providing more diversification of things for tour participants to see and experience.


